The OSHA Respiratory Protection standard (29 CFR 1910.134) requires that employees be medically evaluated and cleared for respirator use prior to wearing a respirator or being fit tested. The use of some types of respirators can cause an increased resistance to breathing or a build-up of carbon dioxide inside the facepiece. This can lead to medical complications in some individuals for whom it may not be safe to wear a respirator. It may also be unsafe for someone with moderate to severe claustrophobia to wear a respirator. Medical evaluations must be provided by the employer during work time and at no cost to the employee.

TEMPORARY EXCEPTION TO AIRCRAFT CERTIFICATION SERVICE POLICY REGARDING VOLUNTARY USE OF N95 FILTERING FACEPIECE RESPIRATORS May 29, 2020

On May 15, 2020, the FAA briefed on the Aircraft Certification Service (AIR) organization's plan to temporarily lift the ban on the voluntary use of N95 filtering facepiece respirators ("N95 masks").

AIR currently has policies in place that prohibit the voluntary use of N95 masks. However, in the interest of public health during the current Coronavirus (COVID-19) pandemic, AIR is temporarily allowing the voluntary use of N95 masks. During this temporary period, any employee that voluntarily chooses to wear an N95 mask must complete and sign a form that will be filed with his or her supervisor.

As background, the N95 masks are primarily intended for healthcare professionals. AIR is not providing N95 masks for COVID-19-related protection. Although an N95 mask is not required for external worksite inspections, surveillance, or flight check rides, the Occupational Safety and Health Administration (OSHA) requires employers to meet certain obligations for workers who voluntarily wear respirators at work. Most workers who wear respirators use them because they are required to do so by their employer to protect them from airborne hazards. If an employer allows an employee to wear a respirator where it is not required, it is considered

voluntary respirator use, and OSHA regulations regarding voluntary use must be followed. Accordingly, during this temporary lift, AIR bargaining unit employees must sign a form regarding the voluntary use of the N95 mask.

AIR will communicate electronically to all employees in the coming days on the temporary lift of the ban on voluntary use of N95 masks.
